1. Welcome and objectives for the meeting

The Chair welcomed the Committee members and attendees to the 8th guideline committee meeting on Self Harm: assessment, management and preventing recurrence.

The Chair informed the Committee of the apologies received, which are noted above.

The Chair reminded all present that the Committee is independent and advisory, that its decisions and recommendations to NICE do not represent final NICE guidance, and that they may be changed as a result of public consultation.

The Chair outlined the objectives of the meeting and discussed the meeting etiquette for the virtual meeting.

2. Confirmation of matter under discussion, and declarations of interest

GC members were asked to submit any new declarations to the Project Manager after the meeting.

3. Minutes of the last meeting

The minutes from the last meeting were approved and accurate, no amendments were made.

4. Presentations

Morning presentations

The Chair introduced Keith Hawton and Katrina Witt from the Cochrane team who gave a presentation on 2 Cochrane reviews that addressed the review questions for



5.2 and 5.3.

Keith Hawton and Katrina Witt took questions from the group. The Chair thanked Keith and Katrina for presenting their Cochrane reviews to the guideline committee.

The Chair introduced Ferruccio Pelone, NGA Health Economist who presented the Health Economists for Review question 5.2 What psychological and psychosocial interventions (including safety plans and electronic health-based interventions) are effective for people who have self-harmed?

Ferruccio Pelone took questions from the group. The Chair thanked Ferruccio for his work on this review.

The Chair alongside the Guideline Lead Katherine Andrea then guided the committee through drafting the recommendations for review questions 5.2 and 5.3.

Afternoon presentations

After Lunch the Chair introduced Katherine Andrea, NGA Guideline Lead who guided the Committee with drafting recommendations for Review question 3.1, How should assessment for people who have self-harmed be undertaken in non-specialist settings, such as: primary care, social care, community pharmacy, ambulances, emergency departments (by non-specialist staff), schools, colleges and universities, the criminal justice system and immigration removal centres, acute general hospitals?

5. Questions and discussion

The Chair Jeremy Isaacs led the Lay member concerns agenda item, there were no concerns raised at the meeting by the Lay members.

The Committee discussed each presentation in relation to this guideline and were given the opportunity to ask questions.

The Committee drafted recommendations for review questions 5.2 and 5.3.

The Chair gave a final reminder to the Committee to submit any claim forms and fees before the NGA's End of the final year deadline at the end of March.
