#### REPORTS OF DISCUSSIONS AT THE MEETING

## 1. Introductions

CM welcomed everyone to the 2<sup>nd</sup> meeting of the Myeloma GDG.

## 2. Declarations of Interest

The following declarations of interest were declared prior to the meeting:

- AG declared that she is the local trial administrator on a myeloma lifestyle study on the management of fatigue funded by CRUK. Celgene have funded a physiotherapist to work on the trial. This interest was categorised as nonpersonal pecuniary, specific, meaning that AG can participate in discussion of all guideline topics as AG has no supervisory responsibility on the trial.
- AG declared that she received reimbursement of travel expenses from the event organisers to attend the European Multiple Myeloma Academy educational meeting in Vienna in February 2014. This interest was categorised as personal pecuniary, non-specific, meaning that AG can participate in discussion of all guideline topics as payment was not beyond reasonable amounts.
- MM declared that she has provided advice for Janssen on the content of a nurse educational leaflet on the management of patients on Bortezomib. No payment was received and the work has been handed over to a colleague for the duration of the guideline. This interest was classified as personal nonpecuniary, (specific/non-specific TBC once clinical questions have been finalised), meaning that MM can participate in discussion of all guideline

- topics as no payment was received and she will no longer be taking part in this work for the duration of the guideline.
- MM declared that she is planning to publish the findings of her MSc research into the experience of myeloma family carers. No financial support was provided for the research. This interest was categorised as personal nonpecuniary, specific meaning that MM can participate in discussion of all guideline topics as no payment was received.

The following new declarations of interest were declared at the meeting:

 GP declared that his registration fee for attendance at the British Society of Haematology Annual Meeting in Birmingham in April 2014 was paid by Janssen. This interest was declared as personal pecuniary, non-specific, meaning that GP can participate in discussion of all guideline topics as payment was not beyond reasonable amounts.
