Options for second analysis (will be presented at GDG 9) MT suggested that further economic analysis was needed for the first analysis of LAC and the GDG agreed for this to go ahead. MT presented 2 options for the second analysis: i. Comparing interventions ii. Costing the consequences MT will explore further and will present at the next GDG.
