#### Current two year surveillance review

- 1. The Evidence Update on CG136 Service user experience in adult mental health (expected publication date: May 2014) was used as the primary source of evidence for this surveillance review (search dates: 1 April 2011 to 5 November 2013). Clinical feedback on the surveillance decision for the guideline was obtained from the Chairs of the Evidence Update Advisory Group.
- 2. The Evidence Update indicates that there is currently insufficient new evidence to invalidate the guideline recommendations. A summary of the evidence is provided in the Evidence Update.
- 3. The Chairs of the Evidence Update Advisory Group (and members of the original Guideline Development Group) felt that CG136 Service user experience in adult mental health is up to date and there is no evidence that would change the guideline recommendations.
