with comorbid conditions)?'

The committee discussed the threshold analysis.

The Chair introduced Ifigeneia Mavranezouli, Senior Health Economist who presented the health economic evidence and the health economic model for RQ:4.1b 'What is the effectiveness of psychological and psychosocial interventions for people who participate in harmful gambling (including those with comorbid conditions)?'

The committee discussed the health economic evidence and health economic model.

Ifigeneia Mavranezouli, Senior Health Economist then presented some resource costs for naltrexone intervention and the committee used this information to finalise their recommendations.

The Chair introduced Matt Gaskell, Topic Advisor who led on a discussion of care pathway recommendations for RQ 3.1 'What is the effectiveness of care pathways and models of care for people who participate in harmful gambling (including those with comorbid conditions such as depression, anxiety and other substance-use disorders)?'

The committee discussed the edits and amended recommendations.

The Chair asked the lay members present if they had anything they wished to raise at the meeting and there were no new items for discussion.
