### 1. Welcome

### 4. Review of the scope for Coeliac Disease update

### 5. Ketone monitoring in hospital

Following on from the meeting in February, the GDG made recommendations regarding monitoring ketones in people with T1D who are in hospital.

### 6. Review of clinical and cost effectiveness evidence for Continuous Glucose Monitoring (CGM) vrs Self-monitoring of Blood Glucose (SMBG)

The clinical and health economic evidence for the use of CGM vrs SMBG in T1D was reviewed and recommendations were discussed.

The GDG briefly reviewed the protocols for the searches for the next questions and will send comments in.
