REPORTS OF DISCUSSION OF THE MEETING

1. Introductions

JV welcomed everyone to the 13th meeting of the bladder cancer GDG.

2. Declarations of interest

The following declarations of interest were declared prior to the meeting:

- JC declared that he received reimbursement of travel expenses from the Royal College of Radiologists to attend the 1st Royal College of Radiologists Bladder Cancer meeting in London and give a lecture on integrating biomarkers and imaging redesign management pathways – do we really need a transurethral resection in muscle invasive disease? This interest was categorised as personal pecuniary, non specific meaning that JC can participate in discussion of all guideline topics as expenses were not beyond reasonable amounts.
- JC declared that he gave a lecture on updates in haematuria at the Urology and Men's Health Update in Sheffield. No payment was received. This interest was categorised as personal non-pecuniary meaning that JC can participate in discussion of all guideline topics as no payment was received.
- JC declared that he receive reimbursement of travel expenses from the European Association of Urology to attend the 14th Society of Urological Oncology annual meeting and give a lecture on the management of high grade non-muscle invasive bladder cancer. This interest was categorised as personal pecuniary, non-specific meaning that JC can participate in discussion of all guideline topics as expenses were not beyond reasonable amounts.

The GDG were reminded that if they take on any new interests, these must be declared to the NCC-C as soon as they happen so that necessary action can be taken.

3. Discussion

The clinical evidence for topic A2 and topic J3 were presented. The GDG agreed draft recommendations and a LETR table for topic A2 and topic J3.

The updated economic model for topic K1 was presented. The GDG agreed changes to the recommendations for topic K1 and updated the LETR table.

Any new evidence identified as part of the update searches for the guideline was presented to the GDG. The GDG reviewed the new evidence and updated the LETR tables where necessary.

The GDG reviewed the draft guideline and the editorial changes to the recommendations.

The GDG agreed their top 10 key priorities for implementation.

The GDG agreed their top 5 research recommendations.

The GDG reviewed the full needs assessment report.

The GDG reviewed the full health economic reports for topic K1 and topic F2.
