Item 3. RQ 2.2 - Revisiting recommendations and the research recommendations for infrastructure

The Chair introduced Marie Harrisingh (MH), Senior Technical Analyst who led a revisiting of the recommendations for RQ 2.2: *What are the most effective interventions for increasing the uptake of routine vaccines by improving infrastructure?*

The Chair thanked MH for her presentation and the committee for their feedback.

Item 4. RQ2.2 – Presentation of evidence and Health economics covering multicomponent interventions

The Chair introduced Clare Dadswell (CD), Technical Analyst, who gave an overview of the evidence for RQ2.2: *What are the most effective multicomponent interventions for increasing the uptake of routine vaccines?* and invited comments from the committee.

Hannah Lomax (HL), Health Economics Technical Analyst, then gave the committee an overview of the published health economics for RQ2.2.

Item 5. RQ2.2 on multicomponent interventions continued

The NICE team and the committee then discussed the evidence presented and made recommendations for this review question.

Item 6. RQ2.1 on multicomponent interventions (continued)

Following a short break, the NICE team and the committee continued drafting recommendations for multicomponent interventions. The Chair thanked CD and HL for their presentations and the committee for their feedback.
