1. Welcome, apologies, introductions and objectives

The Chair welcomed the Committee members and attendees to the 12th meeting on Social, emotional and mental wellbeing in primary and secondary education.

3. Health economics - modelling approach

4. Expert testimony: Children's and young people's mental health during

COVID-19

The Chair introduced David Lockwood, Deputy Head of Mental Health, CYP and Perinatal Mental Health at NHS England who presented expert testimony on children's and young people's mental health during the COVID-19 pandemic.

David gave an overview of Children and Young People's Mental Health community transformation and the impact of the pandemic. The Committee had the opportunity to ask questions.

5. Expert testimony: Trauma Perceptive Practice (TPP) The Essex approach to understanding behaviour and supporting emotional wellbeing

The Chair introduced Beth Brown and Steve Whitfield of Essex County Council who presented expert testimony on understanding behaviour and supporting emotional wellbeing during the COVID-19 pandemic. The Committee then had the opportunity to ask questions.
