1. Welcome and objectives for the meeting

The Chair welcomed the Committee members and attendees to the third meeting on the Adrenal Insufficiency guideline. The Committee members were introduced to new members of the technical team and the Senior Medical Editor.

The Chair outlined the objectives of the meeting, which included presentation of:

- the NICE guide on drafting recommendations
- the results on the evidence review on the routine management of primary adrenal insufficiency,
- health economic prioritisation details
- outstanding questions on draft protocols following quality assurance with the guideline commissioning team.
- the following draft protocols, for the committee's input:
 - Pharmacological strategies to prevent adrenal crisis during periods of intercurrent illness and periods of physiological stress.
 - Pharmacological strategies to prevent adrenal crisis during periods of psychological stress.

- 4.7 What is the clinical and cost effectiveness of non-pharmacological strategies to prevent adrenal crisis during periods of intercurrent illness and periods of physiological stress?
- 4.8 What is the clinical and cost effectiveness of non-pharmacological strategies to prevent adrenal crisis during periods of psychological stress?
